#### **What is Personal Data?**

Under the Data Protection Act 1998, Personal Data is defined as data that relates to a living individual who can be identified:

- (a) from those data, or
- (b) from those data and other information which is in the possession of, or likely to come into the possession of, the data controller, and includes any expression of opinion about the individual, and any indication of the intentions of the data controller or any other person in respect of the individual. (Section 1(1)).

Personal data will therefore cover basic details such as name, address, telephone number, and Date of Birth.

#### **Who will process your personal data?**

The information which you provide on this form will be processed by positivID Identity Systems Ltd, which is the 'data controller' for the purposes of the Data Protection Act.

#### **What will your personal data be used for?**

The personal data that you provide will be used in order to create an identity card and to recreate the card should the original card expire, become lost or unusable, or need updating. Personal data will be removed on termination of contract with your employer, or at your request.
